APPLICATION RATE:

- i) ROW CROPS, VEGETABLES and TREES less than 3 years old:
1 - 2 pints per Acre
- ii) TREE, VINE, NUTS and CITRUS: 1 - 2 quarts per Acre (If applying foliarly, use a minimum of 50 gallons of water)
- iii) ORNAMENTALS: 1-3 pints per 100 gallons of water
- iv) TURF - Contact your Product representative for specifications.
 - 1) GREENS: 0.5 to 1 oz per 1000sqft
 - 2) FAIRWAYS and LAWNS: 1 to 2 oz per 1000sqft

Apply in-furrow, pop-up, drench or foliar (center pivot irrigation, ground or aerial) with water or NPK fertilizers.

Storage Instructions: Store in cool area 40 - 110 degrees F . out of direct sunlight. DIAMOND THRIVE is completely compatible with phosphate-containing fertilizers and is non-corrosive.
